F&M Bank applied for and received a \$15,000 **AHEAD** (Access to Housing and Economic Assistance for Development) grant from the **Federal Home Loan Bank of San Francisco** to teach the FDIC's Money Smart for Young Adults to youth at the **Teen Impact Center**, operated by the **Family Resource & Referral Center of San Joaquin.** In addition to the \$15,000 AHEAD grant to fund the program, F&M Bank committed to providing a scholarship incentive to students who completed the 8-module curriculum.

By partnering with the Family Resource & Referral Center of San Joaquin County, we are able to directly reach area youth who will benefit from financial education resulting in increased financial literacy. Employees from F&M Bank, University of the Pacific and Platinum Mortgage taught participating youth from the area throughout the fall of 2013. The objectives of the program include the importance of setting financial goals and teaching effective money management techniques. Graduation ceremonies were held for the inaugural class on January 2, 2014. Each graduate received a \$200 scholarship and certificate of completion from F&M Bank. The second and final class will begin on February 5, 2014 and will be held at the Teen Impact Center.

Chris Mitchell, a Senior at Cesar Chavez High School, said, "I learned about going into a bank, opening an account, the type of information required to open the account and what types of accounts are available."

Allina Flores, a Senior at Lincoln High School, stated, "I attended these courses because I see how my family struggles with these issues and I don't want to make those same mistakes."
